

ORDINANCE NO. 1815-18

AN ORDINANCE AMENDING THE VILLAGE CODE OF THE VILLAGE OF HAWTHORN WOODS – TITLE 11, SECTION 11-1-1A.3 – AQUATIC CENTER POOL

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Hawthorn Woods, Lake County, Illinois, as follows:

SECTION ONE: That Title 11, Section 11-1-1A.3.a of the Village Code of the Village of Hawthorn Woods entitled “Residents:” is hereby deleted in its entirety and in lieu thereof, the following language shall be substituted:

“a. Swim Party and Room Rental Party Packages  
Monday – Sunday, 2 hour bookings

1. Outdoor party package (\$150/resident; \$175 non-resident)  
A 2-hour reserved outdoor space and all day access to the outdoor facility for up to 24 guests.
2. Indoor basic party package (\$250 resident; \$275 non-resident)  
A 2-hour shared room reservation and all day access to the outdoor facility for up to 30 guests.
3. Indoor deluxe party package (\$400 resident; \$425 non-resident)  
A 2-hour private room reservation and all day access to the outdoor facility for up to 60 guests.
4. For Swim Party and Room Rental Party Packages: \$50 holding deposit due at the time of booking; non-refundable if cancelled by renter; deposit is applied to total amount due on the day of rental.”

SECTION TWO: That Title 11, Section 11-1-1A.3.b of the Village Code of the Village of Hawthorn Woods entitled “Nonresidents:” is hereby deleted in its entirety and in lieu thereof, the following language shall be substituted:

“b. After-Hours Private Pool Party Rentals  
Friday – Sunday, 6:30 p.m. – 8:30 p.m.  
The first ½ hour is during open swim hours; the last 1 ½ hours are private. Lifeguards and staff included in rental.

1. Activity pool/slides rental (\$275/resident; \$325/non-resident)

Includes 2-hour use in the activity pool and outdoor party deck with 2 slides, zero depth entry, and spray features for up to 50 guests.

2. Main pool/diving pool rental (\$325/resident; \$375/non-resident)  
Includes 2-hour of use of the main pool only and outdoor party deck with 6 lap lanes, diving well with two 1-meter boards, for up to 100 guests.
3. Aquatic full-facility rental (\$450/resident; \$500/non-resident)  
Includes use of the entire outdoor pool facilities (main pool, activity pool, diving well, slides) for up to 300 guests.
4. For After-Hours Private Pool Party Rentals: \$150 holding deposit due at the time of booking; non-refundable if cancelled by renter; deposit is applied to total amount due on the day of rental.”

SECTION THREE: That Title 11, Section 11-1-1A.3.c of the Village Code of the Village of Hawthorn Woods entitled “Security deposit” is hereby deleted in its entirety and in lieu thereof, the following language shall be substituted:

“c. Add-On Fees

1. Food opt-out fee (\$25 and minimum order of \$50)
2. Indoor extra hour (\$50/hour shared room; \$100/hour private room)
3. Reserved outdoor space extra hour (\$25/hour)
4. Additional guests (\$5/person)
5. Additional staff (\$25/hour)”

SECTION FOUR: That all ordinances or resolutions, or parts thereof in conflict with the provisions of this Ordinance are, to the extent of such conflict, superseded by this Ordinance.

SECTION FIVE: That this Ordinance shall be in full force and effect ten (10) days from and after its passage, approval and publication in pamphlet form as provided by law.


