



ORDINANCE 1867-18

AN ORDINANCE AMENDING THE VILLAGE CODE OF THE VILLAGE OF HAWTHORN WOODS - TITLE 6 – MOTOR VEHICLES AND TRAFFIC, CHAPTER 7 – VEHICLE SEIZURE AND IMPOUNDMENT, SECTION 6-7-2 – VIOLATIONS AUTHORIZING SEIZURE

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Hawthorn Woods, Lake County, Illinois, as follows:

SECTION ONE: That Title 6, Section 6-7-2 of the Village Code of the Village of Hawthorn Woods, entitled "VIOLATIONS AUTHORIZING SEIZURE" is hereby amended by deleting Table A-G and replacing it with the following Table A-I:

A.	625 ILCS 5/11-501	Driving under the influence of alcohol and/or drugs, as provided in section 11-501 of the Illinois vehicle code.
B.	625 ILCS 5/6-303	Driving while License Suspended or Revoked (except if suspension is for an unpaid citation or due to failure to comply with emission testing).
C.	625 ILCS 5/6-101	No Valid Driver's License (unlicensed) excluding expired driver's licenses less than one year.
D.	625 ILCS 5/11-204	Fleeing or attempting to elude a peace officer, including Aggravated Fleeing.
E.	625 ILCS 5/11-506	Street Racing or Aggravated Street Racing.
F.	625 ILCS 5/11-503	Reckless Driving.
G.	625 ILCS 5/11-401	Leaving the scene of a motor vehicle accident involving death or personal injury.
H.	720 ILCS 5/36-1	Operation or use of a motor vehicle attempting to or committing an offense for which a motor vehicle may be seized or forfeited.
I.	625 ILCS 5/11-208.7	Any violation listed in the administrative fees and procedures for impounding vehicle for specified violations section of the Illinois Vehicle Code.

SECTION TWO: That all ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, superseded by this Ordinance.

SECTION THREE: That this Ordinance shall be in full force and effect ten (10) days from and after its passage, approval and publication in pamphlet form as provided by law.




