CORKILL INSURANCE

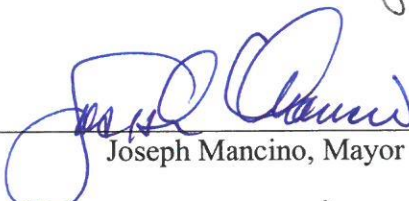
