

LETTER OF AGREEMENT FOR CONSULTING SERVICES

This is a letter of agreement between the Village of Hawthorn Woods ("Hawthorn Woods") and Mike Truppa Communications, LLC ("MTC"). Under this agreement, effective January 1, 2019, the parties will abide by the following terms:

1.) Services. From January 1, 2019 through December 31, 2019, MTC will provide Hawthorn Woods with consulting services in conjunction with the Tri-County Access Project ("TCAP"), including, but not limited to, the following:

- General strategic counsel
- Creation of communications content
- Media relations
- Policy analysis

2.) Compensation. In exchange for providing the services identified in paragraph 1 above, Hawthorn Woods will pay MTC a total fee of \$60,000, payable in twelve equal monthly installments for fiscal year 2019.

3.) Billing. MTC will submit an invoice to Hawthorn Woods on or about the 1st of each month, beginning in January 2019 and ending in December 2019, and reflecting the amount of the monthly installment described in paragraph 2 above.

4.) Payment. Hawthorn Woods will pay MTC invoices within five weeks of receipt.

5.) Severability. Either party may terminate this agreement prior to December 31, 2019 by providing written notice of termination to the other party. Such termination shall become effective at the end of the month during which such written notice is provided.

6.) If both parties agree, this working relationship can be adjusted, amended or renewed prior to, or upon, expiration of this agreement.

7.) This agreement shall be interpreted in accordance with the laws of the State of Illinois.
