

ORDINANCE NO. 1979-19

AN ORDINANCE AMENDING THE VILLAGE CODE OF THE VILLAGE OF HAWTHORN WOODS – TITLE 11, SECTION 11-1-1L – AQUATIC CENTER FEES

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Hawthorn Woods, Lake County, Illinois, as follows:

SECTION ONE: That Title 11, Section 11-1-1L of the Village Code of the Village of Hawthorn Woods entitled “Aquatic Center Fees” is hereby deleted in its entirety and in lieu thereof, the following language shall be substituted:


SECTION THREE: That this Ordinance shall be in full force and effect ten (10) days from and after its passage, approval and publication in pamphlet form as provided by law.


