

ORDINANCE NO. 203420

AN ORDINANCE AUTHORIZING THE SALE OR DISPOSAL OF PERSONAL PROPERTY OWNED BY THE VILLAGE OF HAWTHORN WOODS

WHEREAS, in the opinion of a majority of the corporate authorities of the Village of Hawthorn Woods, it is no longer necessary or useful to or for the best interests of the Village of Hawthorn Woods, to retain ownership of the personal property hereinafter described; and,

WHEREAS, it has been determined by the Mayor and Board of Trustees of the Village of Hawthorn Woods to sell said personal property.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Hawthorn Woods, Lake County, Illinois, as follows:

SECTION ONE: Pursuant to 65 ILCS 5/11-76-4, and 765 ILCS 1030, the Mayor and Board of Trustees of the Village of Hawthorn Woods find that the property legally described on Exhibit "A" attached hereto and made a part of, now owned by the Village of Hawthorn Woods, is no longer necessary or useful to the Village of Hawthorn Woods and the best interests of the Village of Hawthorn Woods will be served by its sale and/or disposal.

SECTION TWO: Pursuant to 65 ILCS 5/11-76-4, and 765 ILCS 1030, the Chief Operating Officer or designee is hereby authorized and directed to sell the property set forth on Exhibit "A" now owned by the Village of Hawthorn Woods.


SECTION THREE: This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
