

ORDINANCE NO. 2192-22

AN ORDINANCE AMENDING THE VILLAGE CODE OF THE VILLAGE OF HAWTHORN WOODS – ADDING TITLE 3, CHAPTER 10, VENDOR FEES; TITLE 11, SUBSECTION 11-1-1F—GENERAL FEES AND CHARGES

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Hawthorn Woods, Lake County, Illinois, as follows:

SECTION ONE: That Title 3 of the Village Code of the Village of Hawthorn Woods is hereby amended by adding a new Chapter 10, entitled, “VENDOR FEES”:

...”CHAPTER 10  
VENDOR FEES

SECTION:

- 3-10-1: Purpose
- 3-10-2: Definitions
- 3-10-3: Fees

3-10-1: PURPOSE:

The purpose of this Chapter is to provide for vendor fees for Village sponsored events throughout the year that provide for enjoyment, enhance the quality of life, and foster a sense of community for all Village’s residents.

3-10-2: DEFINITIONS:

For purposes of this Chapter, the following phrases shall have the definitions as set forth below:

VENDOR: A company or person that sells a product or service, especially one who sells to the public.

3-10-3: FEES:

Fees for such vendors shall be the amount described in the village fee schedule, Title 11, Section 11-1-1F of this title; provided, that fees associated with vendors may be discounted by the Chief Operating Officer.”

SECTION TWO: That Title 11, Section 11-1-1F of the Village Code of the Village of Hawthorn Woods entitled “General Fees and Charges” is hereby amended to include the following language:


SECTION FOUR: That this Ordinance shall be in full force and effect ten (10) days from and after its passage, approval and publication in pamphlet form as provided by law.


