

ORDINANCE NO. 2222-23

AN ORDINANCE AMENDING THE VILLAGE CODE OF THE VILLAGE OF HAWTHORN WOODS – TITLE 3, SECTION 3-11-2, DEFINITIONS; TITLE 11, SUBSECTION 11-1-1F.19—VENDOR FEES AND TITLE 11, SUBSECTION 11-1-1F.20—GOLF OUTING FEES

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Hawthorn Woods, Lake County, Illinois, as follows:

SECTION ONE: That Title 3, Section 3-11-2 of the Village Code of the Village of Hawthorn Woods, entitled “DEFINITIONS” is hereby amended by adding the following definition:

” PROMOTIONAL VENDOR: A company or person that advertises a product or service to the public.”

SECTION TWO: That Title 11, Subsection 11-1-1F.19. and 20 of the Village Code of the Village of Hawthorn Woods entitled “Vendor Fees” and “Golf Outing Fees” are hereby deleted in their entirety and in lieu thereof, the following language shall be added:

...”19. Vendor Fees

- a. Bark in the Park
 - 1. Vendor \$50.00
 - 2. Promotional Vendor \$35.00
- b. Fireworks Event
 - 1. Vendor – Hawthorn Woods Business \$85.00
 - 2. Vendor – Non-Hawthorn Woods Business \$110.00
 - 3. Promotional Vendor – Hawthorn Woods Business \$75.00
 - 4. Promotional Vendor – Non-Hawthorn Woods Business \$100.00
- c. Friday Night Summer Events
 - 1. Full Season Registration \$150.00
 - 2. Pay Per Fest \$25.00
- d. Holiday Craft Fair
 - 1. Cost per Table \$80.00
 - 2. Cost per Table Including Electricity Additional \$15.00
 - 3. Cost per Table Including Wi-Fi Access Additional \$10.00
- e. Hometown Holiday
 - 1. Vendor \$60.00
 - 2. Promotional Vendor \$40.00
- f. Party in the Park
 - 1. Vendor – Hawthorn Woods Business \$100.00 + 5% of gross sales
 - 2. Vendor – Non-Hawthorn Woods Business \$200.00 + 5% of gross sales
 - 3. Vendor – Returning Non-Hawthorn Woods Business \$175.00 + 5% of gross sales

- 4. Promotional Vendor – Hawthorn Woods Business \$65.00
- 5. Promotional Vendor – Non-Hawthorn Woods Business \$90.00
- g. Vendor and promotional vendor fees may be amended at the discretion of the Chief Operating Officer
- 20. Golf Outing Fees
 - a. Foursome \$775.00
 - b. Individual \$200.00
 - c. Individual – Lunch only \$50.00

SECTION THREE: That all ordinances or resolutions, or parts thereof in conflict with the provisions of this Ordinance are, to the extent of such conflict, superseded by this Ordinance.

SECTION FOUR: That this Ordinance shall be in full force and effect ten (10) days from and after its passage, approval and publication in pamphlet form as provided by law.


