

1. New color selections:
  - a) Pro Blue for Inside of tennis court & back courts of pickleball courts
  - b) Medium Green for all outsides & *Kitchen front areas of pickleball courts*
2. Installation of 4 sets of permanent net posts & nets
  - a) Removal of debris from the cracks
  - b) Filling of cracks with NuSurf Acrylic
  - c) Leveling of repaired cracks with mechanical sander as necessary
3. Painting of additional pickleball court lines

Any alteration or deviation from above specifications involving extra costs will be executed only upon written orders, and will become an extra charge over and above the estimate.

All agreements contingent upon strikes, accidents, or delays beyond our control. Owner to carry fire, tornado and other necessary insurance. Our workers are covered by Workman's Compensation Insurance.

This Proposal may be withdrawn if not accepted by May 15, 2024.
