



1. Sanding of entire repaired cracks
2. Shallow saw cutting of surface, as necessary, to control the ends of cracks progress to favorable terminal points
3. Application of 5 step Armor Crack Control System
4. Sealing of the system with Laykold NuSurf primer / resurfacer

Labor & materials guarantee excludes normal wear and tear, damage done due to physical abuse, neglect, failure to maintain, act of nature and other conditions beyond our control.


