**A RESOLUTION MAKING A DETERMINATION  
RELATIVE TO THE RATIFICATION AND APPROVAL,  
RELEASE OF EXECUTIVE SESSION MINUTES AND DESTRUCTION OF  
EXECUTIVE SESSION TAPES PURSUANT TO THE  
ILLINOIS OPEN MEETINGS ACT**

**WHEREAS**, The Mayor and Board of Trustees of the Village of Hawthorn Woods have met from time to time in Executive Session for purposes authorized by the Illinois Open Meetings Act; and

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Board of Trustees of the Village of Hawthorn Woods, Lake County, Illinois, as follows:

**SECTION ONE:** The Executive Session minutes from those meetings set forth on Schedule "A" attached hereto are hereby released for public inspection and the Executive Session minutes from those meetings set forth on Schedule "B" shall not be released for public inspection as the need for confidentiality still exists for those minutes listed on Schedule "B".

**SECTION TWO:** All verbatim Executive Session recordings from July 23, 2022 through July 27, 2023 are hereby approved for destruction in conformance with the

Illinois Open Meetings Act as they are over 18 months old and the minutes of the respective Executive Session meetings have been approved.

**SECTION THREE:** This Resolution shall be in force and effect from and after its adoption and approval as provided by law.




