

ORDINANCE No. 2455-25

AN ORDINANCE AMENDING THE VILLAGE CODE OF THE VILLAGE OF HAWTHORN WOODS –SECTION 11-1-1, FEES FOR CERTAIN ACTIVITIES AND PURPOSES

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Hawthorn

Woods, Lake County, Illinois, as follows:

SECTION ONE: That Title 11, Section 11-1-1.A.2 of the Village Code of the Village of Hawthorn Woods, entitled "Aquatic Center Pool", is hereby deleted in its entirety and in lieu thereof, the following language shall be substituted:

2. Aquatic Center Pool:	
a. Daytime Party Rentals: Monday - Sunday, 2 hour bookings	
(1) Table Rentals: A 2-hour reserved outdoor space and all-day access to the outdoor facility for up to 40 guests. Base rate due at time of booking.	\$85.00 resident member base rate \$95.00 non-resident member base rate \$95.00 resident non-member base rate \$110.00 non-resident non-member base rate + an additional charge of \$10.00/guest up to 40; after 40 guests must pay daily rate
(2) Private Activity Pool/Slide Rental: Reservations available Monday, Tuesday, Thursday, and Friday 11:00 a.m. – 12:30 p.m. Includes reserved seating for up to 40 guests.	\$270.00 resident member \$310.00 non-resident member \$310.00 resident non-member \$355.00 non-resident non-member 50% holding deposit due at the time of booking; non-refundable if cancelled by renter; deposit is applied to total amount due on the day of rental
b. After-hours rentals: Friday - Sunday, 6:30 P.M. - 8:30 P.M. The first 1/2 hour is during open swim hours; the last 1 1/2 hours are private. Lifeguards and staff included in rental.	Extra hour \$150 for resident and \$175 for non-resident; request at reservation time, if slot available (can be added to begin time only and is during open swim hours)
(1) Activity pool/slides rental: Includes 2-hour of use of indoor room and outdoor party deck, and the activity pool with 2 slides, 0 depth entry, and spray features; includes 30 guests; max of 125 guests.	\$450.00 resident member \$515.00 non-resident member \$515.00 resident non-member \$590.00 non-resident non-member + an additional charge of \$7.00/guest

(2) Main pool/diving pool rental: Includes 2-hours of use of the indoor room and outdoor party deck, the main pool only with 6 lap lanes, diving well with two 1-meter boards; includes 30 guests; max of 125 guests.	\$450.00 resident member \$515.00 non-resident member \$515.00 resident non-member \$590.00 non-resident non-member + an additional charge of \$7.00/guest
(3) Aquatic full-facility rental: Includes use of the indoor room and entire outdoor pool facilities (main pool, activity pool, diving well, slides); includes 75 guests; max of 250 guests.	\$975.00 resident member \$1,120.00 non-resident member \$1,120.00 resident non-member \$1,285.00 non-resident non-member + an additional charge of \$7.00/guest
(4) For after-hours private pool party rentals	50% holding deposit due at the time of booking; non-refundable if cancelled by renter; deposit is applied to total amount due on the day of rental”

SECTION TWO: That all ordinances and resolutions, or parts thereof, in conflict with the provisions of the Ordinance are, to the extent of such conflict, superseded by this Ordinance.


SECTION THREE: That this Ordinance shall be in full force and effect ten (10) days from and after its passage, approval and publication in pamphlet form as provided by law.


