

ORDINANCE NO. 2459-25

**AN ORDINANCE AUTHORIZING
PAMELA NEWTON TO EXECUTE CERTAIN CONTRACTS RELATED TO THE
ILLINOIS DEPARTMENT OF CENTRAL MANAGEMENT SERVICES JOINT
PURCHASING FOR BULK ROCK SALT**

WHEREAS, the State of Illinois sought information on personnel authorized to execute certain contracts and joint participation agreements; and

WHEREAS, Pamela Newton is the Chief Operating Officer of the Village; and

WHEREAS, as Chief Operating Officer Pamela Newton is authorized to execute certain contracts and joint participation agreements pursuant to the Village Code and as otherwise authorized by the Village Board.
