OF AN AGREEMENT – SUMMER CONCERT – OUT OF STORAGE

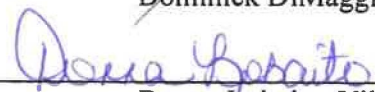

10. CANCELLATIONS/SPECIAL ARRANGEMENTS:
The Village of Hawthorn Woods will solely determine cancellation or implementation of an event.

Inclement Weather: A decision will be made by 4:00 p.m. on the day of the event; should unpredicted weather pose any threat to public safety; the Village will make the necessary call to cancel during setup or during an event. If possible, cancelled events will be rescheduled at a mutually agreeable date. For events that are cancelled due to inclement weather, and that are unable to be rescheduled, the entertainment group will receive full compensation.

State of Emergency: In the event of a local, state, or national emergency, this contract is null and void and the entertainment group will receive no compensation. This includes, but is not limited to, stay home orders and/or gathering restrictions put in place by local, state or federal authorities.
